

“Lexus Trading Bases” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF SWEEPSTAKES: The “Lexus Trading Bases” Sweepstakes (the “Sweepstakes”) begins at 12:00PM Central Time (“CT”) on July 4, 2025 and ends at 11:59PM pm CT on August 13, 2025 (the “Sweepstakes Period”), subject to the hours of operation at each stadium, Globe Life Field and Daikin Park (each a “Stadium”).

ELIGIBILITY: The Sweepstakes is open only to legal residents in the state of Texas who are twenty-one (21) years of age or older (the “Entrant”). **Potential Grand Prize Winners will be notified by telephone or email.** Officers, directors, managers and employees of Toyota Motor Sales U.S.A., Inc., the Southern Area Lexus Dealer Advertising Association, Inc. Entrants must scan the QR code located by the permanent Lexus vehicle display at first base side section at Rangers home game or in Center Field and Gallagher Club space at Astros home game using a web-enabled wireless device equipped with a QR code reader app (free to download). After scanning the QR code, you will be directed to the Website where you must follow the directions explained in the Online section, above. Submit all non-optional data requested on the entry form to receive one (1) entry into the Sweepstakes. 2. Lexus Dealership: Entrants may also enter at one of the Lexus Dealerships below during the Sweepstakes Period. Entrants must scan the QR code located by the Lexus vehicle display at the respective dealership using a web-enabled wireless device equipped with a QR code reader app (free to download). After scanning the QR code, you will be directed

to the Website where you must follow the directions explained in the Online section, above. Submit all non-optional data requested on the entry form to receive one (1) entry into the Sweepstakes.

Limit of one (1) Entry per Entrant per team for the Sweepstakes. Subject to verification of eligibility and compliance with these Official Rules, each potential grand prize winner will be declared the official grand prize winner (the "Grand Prize Winner") of the Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Sweepstakes Period for each team. The random drawing will be conducted by the Independent Administrator, whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects.

WINNER NOTIFICATION/CLAIM: Subject to verification of eligibility and compliance with these Official Rules, Grand Prize Winners will be notified by the Independent Administrator by telephone or email ("Notification"). Independent Administrator will make two (2) attempts to reach a potential grand prize winner. Potential grand prize winner must respond within the date and time listed in the Notification to claim the Grand Prize. Grand Prize Winner's guests must be of legal age of majority in their jurisdiction of residence unless accompanied by a parent or legal guardian. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game, as defined by MLB, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Sponsor, the respective Stadiums, and the MLB Entities reserve the right to remove or to deny entry to Grand Prize Winner and/or their guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at the game. The Released Parties will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any MLB game. In the event that a Astros or Rangers home game does not take place as scheduled, for reasons such as cancellation, preemption or postponement, or for any reason beyond the control of the Sponsor, no additional substitution or compensation will be provided. MLB game tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture and may invalidate the license granted by the game ticket. Event and game may be subject to change due to impracticability or unavailability, or for any other reason as determined necessary by Sponsor or its designee and are subject to any and all applicable health and safety protocols (which may be dictated by provider/location policies and/or state and/or local government

requirements – all of which are subject to change at any time, including as the result of the COVID-19 pandemic). Grand Prize Winner and guest(s) must adhere to the requirements of the Stadium for any vaccinations/testing in order to attend the game.
